ANTLERLESS DEER HUNTING PROCEDURE FOR CITY OF DENISON AND YELLOW SMOKE PARK

You must first pass a proficiency test conducted by the Wild River Archery Club located adjacent to the Mary Segebart residence on Donna Reed Road. You may contact any of the names listed below to schedule an appointment if you are interested in taking the proficiency test.

You must make 4 of 5 shots at 22.5 yards with field points and 2 of 3 shots at 22.5 yards with broadheads.

- You must then take your proficiency test certificate to the County Recorder's office in the Crawford County Courthouse to purchase your license.
- 3) If you prefer to hunt in Yellow Smoke Park, you must request a Yellow Smoke Park permit from the Conservation Board office at Yellow Smoke Park. You carry this permit on your person. You will also get a window card which must be displayed on the front windshield dash of your vehicle.

Denison Special Deer Management Zone Antlerless Archery Deer Season November 1, 2018 – January 10, 2019

Any antlerless deer taken during the special Denison Zone deer season must be reported to the Crawford County Conservation Board office within 24 hours after harvesting the deer or by Monday at 4:30 p.m. following a weekend harvest.

The person may call in the harvest information at 712-263-2748 between 8:00 a.m. and 4:30 p.m. Monday – Friday or if after hours or on a weekend leave a message with the following information: 1) Name of hunter, 2) Date of harvest, 3) Sex of deer (doe or button buck) and 4) Where deer was taken (Denison or Yellow Smoke Park). You may also stop by the office to report the information.

CHAPTER 55.23 ANTLERLESS DEER HUNTING.

Licensed bow hunters meeting the requirements established by the Iowa Department of Natural Resources and who pass a proficiency examination administered on behalf of the City may hunt antlerless deer within the areas designated as the Denison Special Deer Management Zones on public or private property, under all the following conditions:

- 1. Hunting may occur only on dates designated by the Department of Natural Resources as bow hunting season in the Denison Special Deer Management Zones, but not earlier than November 1, by persons who are at least 18 years of age and possess and carry a valid deer hunting license. In addition, each person must possess and carry written evidence of having passed the City of Denison proficiency examination.
- 2. Hunters must have written permission from the property owner and must carry such written permission, along with the portion of the special deer management zone map which verifies that the property is within the zone, at all times while hunting.
- 3. Hunters shall not carry an uncased bow within 200 feet of any residence or within 75 feet of any trail, road, parking lot or building.
- 4. Hunters must take all shots from an elevated stand and shoot no further than 25 yards.
- 5. Hunters must comply with all rules of the Iowa Department of Natural Resources for hunting in such zone.
- 6. Hunters must take all deer meat to be processed or given to charity.
